In connection with the reference mentioned in Invitation for Tender issued on 13 March 2024, a pre-bid meeting held on 20 March 2024.

At the out-set of the meeting, the Operations Manager, AVCB III Project welcomed all the bidders who participated in the meeting. He briefly described the context of the meeting, background of the project and GoB procurement process. Then the discussion started on the major issues of the requirements of the bids, eligible and qualifications criteria and delivery destination etc. Section 3 and 5 of the Bid Documents was elaborately discussed. Fraud & Corruption issues was also discussed and made the bidders' awareness on this issue. Then IT Associate of AVCB-III project described some critical aspect of technical specification, packaging and distribution. Then the floor was opened to receive questions from the bidders and the following discussion and queries were raised by Invitees and answers thereto from AVCB III Project.

2	In STD document (page-62), it is mentioned that delivery period to be mentioned by the bidder. What does it mean?	Allowable delivery period as per STD document is 8 weeks starting from the date of contract signing. The bidder may mention their proposed/required delivery period in their Price Schedules; but it will be evaluated as per the conditions mentioned in STD clause#52.6.
3	In specification, it is mentioned that Port will be 1xThunderbolt 4/USB4TM 40Gbps. Is it possible to make this port generic or alternative Port 1x USB Type-C?	This port is already generic as this port configuration matches with some renowned brand Laptops such as Lenovo/HP/Dell and other equivalent international standard laptop.  No alternative is acceptable.
4	Sound system: Dolby Atoms Speaker system. Please amend Atoms/Sterio Dolby.	Dolby Atoms Speaker system is preferrable, but Atoms/Sterio Dolby can be accepted if it's performance is equivalent or above.
5	Battery of the Laptop will be 3 Cell, 57 Wh or 3 Cell, 54 Wh?	Battery of the Laptop with 3 Cell, 57 Wh will be preferred, but it will not be less than 54Wh.
6	In STD, it is mentioned "On-site Warranty: minimum 02 (two) years Division/District	Minimum 2 years onsite or carry on warranty services in all Divisions or 61 District across the Bangladesh except 3 CHT districts is essential.
